THE ORGANIZATION DISSEMINATED ITS GUIDE FOR ADVOCATES, IMPORTING FREEDOM: USING THE U.S. TARIFF ACT TO COMBAT FORCED LABOR IN SUPPLY CHAINS WIDELY, MAKING THE GUIDE AVAILABLE IN FIVE LANGUAGES.
