A SELECTION COMMITTEE OF EXPERTS, ALLIES, AND TRAFFICKING SURVIVOR-LEADERS REVIEWED THE APPLICATIONS AND CONDUCTED INTERVIEWS. IN ALL, THE SELECTION COMMITTEE INTERVIEWED 15 APPLICANTS AND SELECTED THE 7 FELLOWS FROM THAT APPLICANT POOL. THE ORGANIZATION USED A SET OF CRITERIA IN ALL OF THE INTERVIEWS TO IDENTIFY CANDIDATES WHO WERE LEADERS IN THEIR COMMUNITIES AND WOULD BENEFIT FROM SCHOLARSHIP FUNDING TO PURSUE EDUCATIONAL PROGRAMS. THE \$500 MONTHLY STIPENDS THAT THE FELLOWS RECEIVE ARE TO SUPPORT THEM AS THEY DEVOTE TIME TO THEIR STUDIES. THE FUNDING FOR THE FELLOWS' COURSES IS PAID DIRECTLY TO THE SCHOOLS. THE ORGANIZATION STAYS IN CLOSE TOUCH WITH THE FELLOWS THROUGH MONTHLY MEETINGS AND CHECK-INS. THESE MEETINGS PROVIDE OPPORTUNITIES TO CONFIRM THAT THE FELLOWS ARE TAKING THE COURSES FUNDED BY THE FELLOWSHIP. IF A FELLOW DROPS A CLASS, THE FUNDS ARE REIMBURSED TO THE HUMAN TRAFFICKING LEGAL CENTER. FELLOWS OCCASIONALLY DO CONSULTING FOR THE ORGANIZATION (SUCH AS SPEAKING AT EVENTS). FOR THESE OCCASIONAL ENGAGEMENTS, THEY RECEIVE CONSULTING FEES FROM THE ORGANIZATION. THESE FEES

ARE SEPARATE AND UNRELATED TO THE STIPENDS.

IN EACH CASE, HTLC FILED THESE AMICUS BRIEFS WITH THE ASSISTANCE OF PRO BONO COUNSEL.
