THE HARRIET TUBMAN FELLOWS, SEVEN REMARKABLE LEADERS SELECTED FROM A COMPETITIVE FIELD OF EIGHTY-FOUR CANDIDATES, EACH RECEIVED A TWO-YEAR SCHOLARSHIP TO PURSUE EDUCATIONAL OPPORTUNITIES. IN 2025, THE HARRIET TUBMAN FELLOWS RETURNED TO WASHINGTON, D.C. FOR A WEEK OF ADVOCACY TRAINING AND MEETINGS WITH CONGRESSIONAL STAFF MEMBERS. HTLC INCLUDED SURVIVOR-LEADERS AT ALL LEVELS OF THE ORGANIZATION: ON THE STAFF, ON THE ORGANIZATION'S LEADERSHIP TEAM, ON THE BOARD OF DIRECTORS, AS CONSULTANTS, AND ON THE ADVISORY BOARD.
